The Gwinnett Children's Shelter housed 220 adolescent boys and girls last year for an average stay of 75 days.

Trevor and Angie were 12 and 15 years old when they arrived late one evening to the Gwinnett Children's Shelter in the back of a patrol car. Each carried a black garbage bag that held their belongings. Trevor looked scared and nervous – Angie looked angry but on the verge of tears.

Trevor had been taken from his family and placed in the Shelter because his mother had left his siblings and him at home for 2 weeks. A neighbor reported them to the authorities after seeing the children, age 3 and up playing outside at 2am. His mother had been gone for two weeks and the children didn't know when she would be returning.

Angie was found sleeping behind a convenience store when a store worker called and reported her to the Department of Family and Children Services. She had run away from home – scared that her mom's boyfriend would come into her room again and molest her. She was afraid to tell because her mom, who was both an alcoholic and drug abuser, had told her that if her boyfriend left they would lose their home.

Trevor was taken to the Boy's Wing of the Shelter that night and Angie went to the Girl's wing. In the days and weeks that followed, both Trevor and Angie worked with counselors and therapists at the Shelter, releasing some of the many burdens that their young lives carried. They slowly shared small pieces of their past – putting together the puzzle – finding HOPE for their future.
